

TAX LEVY ORDINANCE
WARREN TOWNSHIP
ORDINANCE NO. 2020-O-11

An ordinance levying taxes for all town purposes for Warren Township, Lake County, Illinois, for the tax year 2020, collectable in 2021.

BE IT ORDAINED by the Board of Trustees of Warren Township, Lake County, Illinois, as follows:

SECTION 1: That the sum of **Six Million, Twenty-Nine Thousand and No/100 Dollars (\$6,029,000.00)** are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as:

1. Township Corporate
2. General Assistance
3. Tort judgment & liability insurance
4. Social Security
5. Illinois Municipal Retirement Fund
6. Parks/Park Maintenance

for the year 2020.

SECTION 2: That the amount levied for each object and purpose shall be as follows:



**TAX LEVY ORDINANCE

ORDINANCE NO. 2020-O-11**

SECTION 3: That the Town Clerk shall make and file with the County Clerk of said County of Lake, on or before the last Tuesday of December, a duly certified copy of this ordinance.

SECTION 4: That if any section, subdivision, or sentence of this ordinance shall for any reason be held invalid or to be unconstitutional, such finding shall not affect the validity of the remaining portion of this ordinance.

SECTION 5: That this ordinance shall be in full force and effect after its adoption, as provided by law.

TRUTH IN TAXATION
CERTIFICATE OF COMPLIANCE
WARREN TOWNSHIP
(35 ILCS 200/18-90)

I, the undersigned, hereby certify that I am the presiding officer of Warren Township, and as such presiding officer I certify that the levy ordinance, a copy of which is attached, was adopted pursuant to, and in all respects in compliance with the provisions of Section 18-60 through 18-85 of the "Truth in Taxation" law.

The appropriate levy procedures were taken as indicated below:

___ 1) The taxing district published a notice in the newspaper and conducted a hearing meeting the requirements of the Truth in Taxation Law.

X 2) The taxing district's aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a notice and a hearing were not necessary.

___ 3) The proposed aggregate levy did not exceed a 5% increase over the prior year's extension. Therefore, a hearing was not held. The adopted aggregate tax levy exceeded 5% of the prior year's extension and a notice was published within 15 days of its adoption in accordance with the Truth in Taxation Law.

___ 4) The adopted levy exceeded the amount stated in the published notice. A second notice was published within 15 days of the adoption in accordance with the Truth in Taxation Law.
